



## 2023 SCHOOL FEE STRUCTURE

*(to be read in conjunction with the Nagle College School Fees Policy)*

### **TUITION FEES**

The 2023 tuition fees are listed above. These fees incorporates the following:

- Resource and reference material, reports, certificates, awards and presentations
- Administrative fees
- Transport for camps/retreats
- Subsidy for school excursions, Swimming Program, Mathematics and English Competitions
- VCE subjects
- Senior Retreats and Junior Camps
- College Diary (replacements to be paid for)
- Student ID Cards (replacements to be paid for)
- One School Magazine and annual Calendar (additional copies to be paid for)

### **ADDITIONAL FEES**

Some extra costs which are charged on a user pay basis that also appear on the Fee Account include:

Technology Levy:	An annual fee per student, incorporates the Laptop Levy
Orbost/Nowa Nowa Bus:	An annual fee per student
VET:	An annual fee per student per subject
VCAL:	An annual fee per student
Instrument Hire:	This fee varies, depending on the type of instrument hired
Instrumental Lessons:	Please contact Mr Andrew Long (Director of Music) for private instrumental music tuition details. Most lesson fees are paid directly to the music tutor. This fee varies, depending on group size and tutor fee.

Electives and excursions incur additional charges which must be paid prior to participation. Extra-curricular activities such as Presentation Balls, Valedictory Dinner, Music Tour, etc. are all “user pays” activities, payable prior to the event. Charges for these events cannot be charged to school fees.

### **PAYMENT OF FEES/DUE DATES**

Parents/Guardians should note that School Fees are due and payable in advance during the first week of each term, (i.e. ¼ of the annual fee shown on the fees statement is required each term), unless another payment frequency has been agreed with the College’s Finance Office. The other payment frequency options are weekly (40), fortnightly (20) or monthly (10) instalments per annum. If choosing to pay by instalments, all fees and charges are to be paid in full by end of November each year.

### **PAYMENT METHODS**

Fees can be paid by Cash, Cheque, EFTPOS, Credit Card, Direct Debit, BPay, Direct Deposit and Centrepay.

## **DISCOUNTS AND CONCESSIONS**

The following discount for payment in full before the end of Term 1 will apply for each of the following years:

<b>Year</b>	<b>Discount Percentage</b>
2023	9%
2024	8%
2025	7%
2026	6%
2027	5%

Note: The above discounts percentages apply to the Annual Tuition Fee only (after any concessions) if all fees are paid in full before the end of Term 1.

### **Payment in full via Direct Debit by 30 November:**

A 2.5% discount will be applied to the Annual Tuition Fee (after any concessions) when fees are paid via Direct Debit over the school year and the account is cleared by 30 November and no arrears exist. The discount will be applied to the final payment.

### **Health Care Card Concession (HCC):**

Families which have a student or students eligible to receive the Camps Sports Excursion Fund (CSEF) will be eligible for the following concessions from the school fee account depending upon the number of eligible students attending the College:

	<b>Total Family Concession Amount</b>
Single Student eligible	\$ 1,695
Two Students eligible	\$ 2,633
Three or more students eligible	\$ 3,152

To be eligible families must have applied and received the CSEF for the student through the school.

The HCC concession will be applied in proportion to the debtors current responsibility for the fees (e.g. if responsible for 50% of fees and eligible for the HCC concession they will receive 50% of the HCC concession amount only).

For existing families who are eligible the concession will be applied prior to issuing fee statements to families each year.

New families will need to make application for the CSEF and if eligible the concession will subsequently be applied to their school fee account.

This concession is in addition to the CSEF amount received from the government.

### **Financial Hardship/Fee Remission:**

Any families who are experiencing hardship in meeting their school fee commitments are asked to contact the Finance office to discuss the options available to them. In circumstances of financial hardship a reduction in the amount of school fees payable (Fee Remission) may be considered upon receipt of a written application from the parents.
